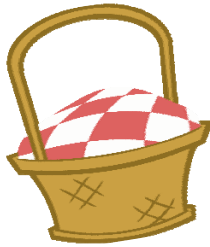

Algae Globbs

Some of you have contacted the office regarding the Algae Blooms that have occurred in the Little Bedford Park area. We have talked to our weed treatment company & this is the answer they have sent us:

"The filamentous variety is not harmful (globbs). It is the planktonic that can be dangerous and it is only a certain few kinds of planktonic (blue greens). Even if you have an outbreak of blue greens, it is not always dangerous.

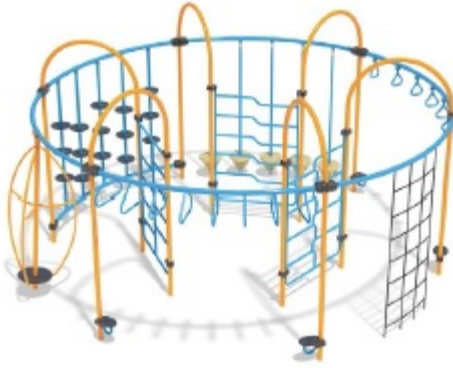
It is important to mention that ALGAE DOES NOT GET EXCESSIVE WITHOUT A NUTRIENT INPUT. Algae requires excess nutrients to "bloom". Given that our observation was specific to that area, it kind of raises a red flag and makes us curious if something is going on at that location with excess nutrients entering into the lake. The applicator said that area smelled like manure. We saw a similar thing a few years back in the bay just south of the access in Hill n Shore with excessive coontail growth. Coontail is also an indicator of a nutrient input."

They told us the type of bloom they observed is not the harmful type. If the nutrient that has been introduced is just surface run off or fertilizer there is no health issue though if it was from septic then it could pose a problem. Since we no longer have septic systems, it is more likely run off due to all of the rain we have had as of late. We will keep an eye on it & if it continues we will have them investigate further.

Park Improvements were done at Southern Shores & Somerset Parks this summer new parking areas, cement around both bathhouses, new ramp at Somerset & new playground equipment & benches at Somerset, and a basketball hoop at Southern Shores Park.

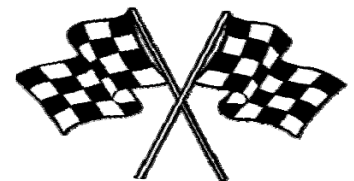

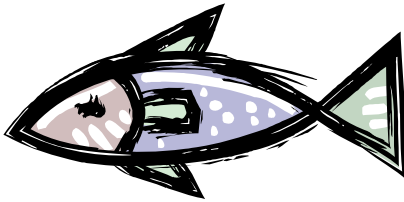

GOOSE ROUNDUP CANCELLED

Due to High Pathogenic Avian Influenza (HPAI) being found in free-ranging Canada geese in Macomb County, the DNR has suspended all Canada Goose Round-Ups statewide. The virus can infect both free ranging and domestic poultry such as chickens, turkeys, quail and geese. It represents the most serious threat to domestic poultry production in decades.

While the virus does not present a significant human health threat, it does present a clear and important threat to agriculture. The DNR will continue statewide HPAI surveillance, which includes responding to suspicious dead animals, testing a sample of ducks and geese that DNR traps and applies leg bands, and testing a sample of hunter-harvested waterfowl.

With this type of HPAI, sick birds may experience neurological signs and abnormal behavior (e.g., difficulty walking), as well as nasal discharge, sneezing, or coughing. If you notice geese or other waterfowl exhibiting these symptoms or find three or more wild birds dead, report to the DNR at 517-336-5030
